Applications, as per the prescribed proforma, are invited from the permanent residents of J&K State for the post of Sub Inspector in **J&K Police Telecommunication** in PB-2 viz 9300-34800 with Grade Pay of Rs.4240/- plus usual allowances as admissible from time to time. Break-up of posts(including backlog) which are to be filled is given as under:-

2- The minimum educational qualification, age and physical standard for the post is given as under:-

Educational qualification	Age	Physical Standards
B.E. or B.Tech from recognized University IN Electronics & Communication Engineering OR Electronics and Telecommunication Engineering OR Electrical and Electronics Engineering	The candidate must be within the age group of 18-28 years as on 1 st day of January 2011. <i>(The candidates born before 01.01.1983 and after 31.12.1993 shall not be eligible). However, in-service police personnel, upto the upper age limit of 30 years, can also apply through proper channel.</i>	For male candidates Height = 5'-6"(min.) Chest = 33½"(expanded) For female candidates Height = 5'-2"(min.) <i>(However, for male candidates belonging to Leh/Kargil districts and Gorkha community, the minimum height shall be 5'-4" while for females the same shall be 5')</i>

3- The application form must be accompanied by attested copies of the following testimonials:-

- a) Matriculation certificate/Date of birth certificate.
- b) Degree certificate in any of the discipline as prescribed above.
- c) State Subject Certificate.
- d) Prescribed certificate, if belonging to any of the reserved category(s).
- e) Four copies of recently taken passport size photograph of the applicant with name written at the back side.
- f) One self-addressed envelope of 28cm x 12cm size affixed with required postal stamps.

4- The candidates should **deposit the Application Forms in the office of respective Inspectors General of Police(Armed/IR) Srinagar/Jammu under proper receipt**. In case of candidates belonging to Leh and Kargil districts, the application forms shall be deposited in the

office of SSsP Leh and Kargil respectively. Application forms, incomplete in any manner, shall be summarily rejected without intimation to the concerned candidate(s). Migrant candidates can deposit the application forms as per their location where they are presently settled.

5- **Last date of receipt of application forms in the offices of IsGP (Armed/IR) Srinagar/Jammu and SSsP Leh/Kargil shall be 30.11.2011.**

Note:-The last date for the receipt of applications provided in the notification shall also be the cut off date for determining the eligibility with regard to educational qualification.

6- The candidates will be subjected to the following tests:-

i) **Physical measurement tests:-**

(For those candidates who possess the required standards viz age, educational qualification and physical standards)

ii) **Written examination = 100 Marks**
(For those candidates who qualify the physical measurement/outdoor tests)

iv) **Viva-Voce/Personality Assessment test = 20 Marks**
(For those candidates who qualify the written test)

7- The **IsGP (Armed/IR) Srinagar/Jammu and SSsP Leh/Kargil** shall receive the application forms of eligible candidates only after proper scrutiny of the documents and maintain recruitment registers properly reflecting therein full particulars of the candidates indicating academic, professional qualification, date of birth, category status in respect of each candidate. The entries should be made neatly without cuttings/erasing.

8- Any qualification or claim accruing to the candidate after the last date of receipt of applications shall not merit any for consideration. No under process claim will be considered at any stage.

9- Persons already in Government service and conforming to the above eligibility standards can also apply with NOC from their respective Departments. The fact of any candidate being in Govt service and having applied without NOC, if ascertained at a later stage, will deny him the offer of appointment.

10- The Candidates who may have contracted any loan/stipend under the self employment scheme or any other scheme will be allowed to join the department only in case they obtain a final clearance/ liquidation certificate from the concerned department.

11- The candidates shall have to appear in the prescribed tests/interview at their own expenses on the dates/venue to be communicated separately.

12- A candidate found guilty of impersonation or submission of fabricated/ tampered documents/ testimonials or making statements which are incorrect, false or suppressing material information, may in addition to rendering him/ her liable for criminal prosecution under law, be debarred permanently or for a specified period from being considered for recruitment in J&K Police.
